Sir / Madam,

As per provision of section 65(4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of Local Inquiry Committee report, the Hon'ble Vice Chancellor is pleased to grant the First Time Affiliation to **Indian Institute of Medical Sciences Ayurved College, Manori, Tal. Dindori, Dist. Nashik – 422 004 (Maharashtra)** established by the **Saibaba Bahuuddeshiya Sevabhavi Sanstha, Dhule – 422 013 (Maharashtra)** for the Academic Year **2023-24** with **60** intake capacity for **B.A.M.S. (UG) course subject to approval of Academic Council as per the provision under section (65) 2 of MUHS Act 1998 by following due procedure.**

However, the affiliation is subject to the following conditions: -

- 1) Fulfilment of norms and conditions laid down by Central Council of Indian Medicine / National Commission for Indian System of Medicine, (NCISM) and Govt. of India.
- 2) Rules and Regulations made by the Govt. and the University, as amended from time to time, will be binding on the College.
- 3) The college should obtain the permission for admitting the students from the Admission Regulating Authority, Mumbai.

The college should obtain approval of fee schedule for the admission of the students from the Fee Regulating Authority, Mumbai.



- 5) The college should obtain approval / recognition of teachers from Maharashtra University of Health Sciences, Nashik.
- 6) This First Time Affiliation to start B.A.M.S. (UG) course with 60 intake capacity is valid for Academic Year 2023-24 only.
- 7) The next batch of students shall not be admitted unless Continuation of Affiliation of MUHS, is obtained by college/Institute.
- 8) The college shall not admit the students for the Academic Year 2023-24 after the cut-off date prescribed by the CCIM / (NCISM), New Delhi.
- 9) The students shall be admitted only after obtaining the permission of concern council & competent Authority of the State Govt.
- 10) It is mandatory for the College / Institute to register on AISHE portal and submit the required data on AISHE portal from time to time.
